

# REJECTION OF FASCIST CONSTITUTION

In a straw poll conducted by the London based Union of Turkish Workers the new fascist Constitution in Turkey was rejected by 495 votes to 106. The announcement of this result was greeted by tumultuous applause at this Committee's Rally on Sunday 7 November.

# **FASCIST MILITARY ATTACKS PEACE**

The Turkish Prime Minister says that in Turkey only terrorists are accused. But we have a question to him: Are all those arrested intellectuals, particularly, the leaders of the Peace Committee of Turkey, terrorist? They haven't shown any criminal activities except their love for world peace and their work for it. Appeal against such arrests motivated by these baseless and unjust accusations were refused by the military tribunal on March 15, 1982. This decision has a very onerous connotation for peace and detente.

#### Peace Committee Indicted

As a matter of fact, the following arguments have been enumerated in the decision of the military tribunal:

"—having demanded the withdrawal of foreign military forces from Cyprus in the final communique of the "International Conference for Peace, Security and Cooperation in the Mediterranean Region", in which the Turkish Peace Committee participated,

— having urged the ending of the occupation of the island in the couse of the conference in solidarity with Cyprus, convened by the World Peace Council, before the establishment of the Turkish Peace Committee,

— having created a public opinion opposed to NATO, to the military accords with the US and to foreign military bases in Turkey,

— having written in the report of the Istanbul Bar Association, presented at the National Peace Conference, that it is impossible for the cold war to persist,

— having struggled for a world without war and without exploitation and having pointed out that the arms race runs counter to this struggle,

— having celebrated the anniversaries of the birth of Nazım Hikmet.

And that the aforesaid are all actions which impede the authority of the state and the government and adversely affect public order."

#### Death for Democrats Fascists Released

13 people have been executed since the junta came to power.\* At present, death sentences for 29 people have been forwarded to the National Security Council for approval and in the cases carried on in military courts the death penalty is asked for 3,000 more.

While democratic forces are coming under even more severe persecutions, the military court is releasing one by one the top leaders of the fascist Nationalist Action Party, the main source of terror before September 12 and the culprit in the murder of thousands of democrats.

According to the report "Human Rights League" between 12 September 1980 and 24 January 1982 in Turkey 170,958 persons had been arrested which included 102 MPs, 79 journalists, 92 lawyers, 6,758 officials etc.; in fact 46,721 political personalities. Amnesty International has declared that 70 persons had been killed under systematic torture of junta and the Turkish government has accepted that only 15 of them have been killed. On the other hand, in the same period, over 500 persons were killed on the streets by the police and soldiers.

\*This number had reached 17 by the end of November 1982.

#### **Workers Attacked**

The military coup of September 12, 1980 banned DİSK\*\* and its affiliates, whose membership reached 600,000 and who played an important role in the trade union movement in Turkey after its foundation in 1967. The junta confiscated all their properties. Their members were deprived of all trade union guarantees and rights. Leaders and shopstewards of DİSK were arrested. They were tortured for months and not permitted to see either their families or their lawyers.

In the announcement to the press, the prosecutor claimed that DİSK was an illegal organisation, which aimed to undermine the constitutional regime, violating articles 141 and 142 of the Penal Code, articles which have been taken over from the penal code of fascist Mussolini. Parallel to continuing investigations, the DİSK case will include up to 2000 people, as the prosecutor states in his indictment.

In the case, DİSK leaders are charged for all the trade union and democratic activities DİSK carried out since its foundation. The prosecutor asks the death penalty for these leaders. According to him, DİSK is an illegal(!), clandestine (!) organisation, which strived to abolish the Constituion of the Republic of Turkey and to establish a Marxist-Leninist regime by

- carrying out strikes,

— organising May Day demonstrations, taking a stand against the fascist danger,

- participating in and cooperating with the international trade union movement,
- staunchly defending the trade union and democratic rights of the working class,
- condemning class conciliation, and,
- working to obtain further rights for workers.

Thus the military prosecutor accuses not only DİSK leaders, but all lawful activities in which hundreds of thousands of workers took part.

# **WRITERS DEMAND RIGHTS**

The Turkish sociologist İsmail Beşikçi was sentenced to 10 years in prison in March this year. (See July 1982 Turkey Newsletter.) His crime was in having referred to the Kurds in Turkey - 20% of Turkey's population — as a separate ethnic group. The evidence for his crime was in a letter sent to the President of the Swiss Writers' Union in August 1980, in which he had denounced, "Turkish universities which follow the official ideology (and thus) give up scientific truth and deny the reality of the Kurdish nation."

Three national writers' unions recently protested this persecution by Turkey's fascist junta, and we reprint their protests here:

To His Excellency President Kenan Evren, Ankara, Turkey The Writers Guild, the leading body of professional writers of books, films, radio and television in the United Kingdom, has learned that the Turkish author Dr İsmail Besikci has once more been imprisoned, and is now being held in the military prison in the city of Gölcük.

He has been sentenced for his defence of the ancient language and culture of the Kurdish people; not for any political act or any incitement to the use of force.

The Writers Guild of Great Britain, a non-political body, calls upon you personally, Mr President, to order the release of Dr Beşikçi, and thereby help to regain the respect of all writers and journalists working in the mass media in the English speaking world. Yours sincerely

#### CONSTITUTION OF THE CODRI

- The name of the organisation shall be the Committee for Defence of Democratic Rights in Turkey (CDDRT).
- 2. The aims of CDDRT are as follows:
  End military rule, martial law, torture and

executions.

Release of political prisoners.
Freedom for all democratic organisations.
End national oppression of the Kurds and national minorities.

Ston expansion in the control of the Kurds and national minorities.

Stop expansionism; end the occupation of

Cyprus.
Withdraw Turkey from NATO and close all

NATO bases.
No military, political or economic support for the

Totally oppose junta harrassment of overseas opponents Organise solidarity on the basis of the foregoing

utilising every means at our disposal. Organisations and individuals accepting the aims of CDDRT can apply to affiliate. Such applications are subject to the approval of the General Council. Affiliation fees shall be set by the General Council and became payable from 1 January each year.

4. Congress is the highest body of CDDRT and

shall meet every two years. It shall consist of delegates from Branches and affiliated organisa-tions, and individual affiliates. Congress shall elect the General Council and consider reports and motions. The conduct of business shall be on the basis of Standing Orders approved by Congress. Pre-Congress arrangements are the responsibility of the rettring General Council. Each Congress shall decide the size of the General Council.

- 5. The General Council is the continuing body of Congress and shall meet quarterly. It shall appoint the Executive Committee which is responsible to it. The General Council shall have the right to co-
- The Executive Committee shall consist of the General Secretary and such other members as the General Council may decide. The Executive Committee shall meet weekly and be responsible for the day to day work of CDDRT.
- Local Branches of CDDRT are formed with the approval of the General Council.
- 8. This Constitution may be amended by a two-thirds majority at a Congress.
- The General Council may call, or upon request by two-thirds of affiliated national organisations shall call, a Special Congress.

anniversary of the start in Istanbul of the trial of 52 leaders of DİSK (Revolutionary Trade Union Confederation). The prosecution has called for the death penalty for all defendants (see article on p2). Since then, on 8 October 1982, ten DISK researchers have been added to the trial and the death penalty demanded for them, too. And a further ten defendants (making a total of 72 on trial) face up to 10 years in jail.

CDDRT is calling for a massive solidarity protest on 24 December this year in the form of a phone-in to the Embassy.

Rally, entitled No Fascist Constitution, which was held in the Rio Cinema, Dalston, London on the same day that the Referendum was being held on the Constitution in Turkey.

A member of CDDRT's General Council, Richard Balfe MEP, chaired the lively event. First speaker was Ernie Roberts MP, who read a hate letter he and Tony Benn received from local Turkish fascists. Ernie declared, "I CDDRT, called on everyone present to know what democracy is. I know it is the right of people to choose their own government freely in elections. That is what I want to see in Turkey."

Alf Lomas MEP was next. He said "This Constitution proposes to limit the scope of the trade union movement... (which is to be) ... banned from political

activity." There will be, "a ban on trade Well over 280 people packed the union organisation at the workplace ... compulsory arbitration ... limits on strikes." Even if the Constitution is passed\*, "that will not be the end of the struggle. An opposition is growing both within Turkey and outside. ... People are more and more understanding the disgusting manner in which the Turkish fascists are carrying on their oppressive regime."

Jim Moody, General Secretary of do what they could to defeat fascism in Turkey as it was an enemy of working people the world over.

John Bowden made the final speech. As a lawyer he was able to destroy many illusions about the new fascist Constitution. His conclusion was that, "This Constitution can only be dealt with and overthrown by the Turkish working class. ... I look forward to the day when we will not have any more of these phony constitutions!"
